Section 4: FIRST AID

Emergency Procedure	SAA/SNZ HB76: Dangerous Goods – Initial Emergency Response Guide - 14. Eliminate all sources of ignition. Ventilate area thoroughly and wear a suitable respirator if necessary to minimise inhalation. Wear suitable personal protective equipment such as protective gloves to prevent skin contact.
Spills / Clean up	Eliminate all sources of ignition. Stop leak if safe to do so. For larger spills (greater than 1L) – contain spill by placing inert, non-combustible absorbent material such as vermiculite, sand or dirt onto spill. For small spills (less than 1L) – can be wiped up using clean rags. Collect material using non-sparking tools and place into a suitable container for disposal according to local regulations. Do not flush to drains or sewers. Clean area by working from the periphery to the centre of spill or from the edge of the room to the centre.
